

## Cleveland Mustang Track and Field Club Uniform Borrower Agreement Terms & Conditions

**General** - This contract is for the borrowing of one Cleveland Mustang Track and Field Club uniform entered into on the date written below between the Cleveland Mustangs Track and Field Club and the party whose signature appears below ("Athlete's Parent").

**Joint Inspection - A.)** Before the Athlete's Parent accepts the uniform; the Athlete's Parent and a Cleveland Mustang Coach will jointly inspect the uniform for damages. The Athlete's Parent's signature on this contract signifies full satisfaction with the condition of the uniform. If Athlete's Parent accepts the uniform in a damaged condition, such damages should be noted on the agreement. No claim of that prior damage will be accepted unless noted on the agreement and acknowledged by a Cleveland Mustang Coach. **B.)** At the Athlete's Parent's request, the Athlete's Parent and a Cleveland Mustang Coach will also inspect the returned item to determine its condition. If the Athlete's Parent does not so request, the condition of the uniform will be determined solely by a Cleveland Mustang Coach.

**Ordinary Use** – The Athlete's Parent agrees that the uniform will be used only in the ordinary course of activities associated track and field.

**Borrowers' Period** – The Athlete's Parent may pickup the uniform during, before, or after track practice. The Athlete's Parent will return the uniform to a Cleveland Mustang Coach during, before, or after practice on the return date shown on the "borrower agreement." If the Athlete's Parent fails to return the uniform on the return date; the Athlete's Parent will pay for the cost of the uniform.

**Damages - A.)** On the return date indicated on the "borrower agreement," the Athlete's Parent will promptly return the uniform to a Cleveland Mustang Coach in the same condition in which the uniform was received, with the exception of ordinary wear and tear, and agrees to pay for any damage to or loss of the uniform while the uniform is in use. **B.)** If the damage appears to be something that can be cleaned (e.g. stains, soiling), the Cleveland Mustangs Track and Field Club will have the uniform cleaned. **C.)** If cleaning will not restore the uniform to usable condition, or if the damage is other than something that can be cleaned (e.g. tears, holes, severe stains), the Cleveland Mustang Track and Field Club will consult with a professional tailor or seamstress to determine the extent of the damage(s) and whether or not the damage(s) can be repaired. If it is determined that it can be repaired at reasonable costs, the Cleveland Mustangs Track and Field Club will have the uniform repaired. The Athlete's Parent will pay the Cleveland Mustangs Track and Field Club the reasonable cost of repair incurred. **D.)** If the Athlete's Parent fails to return the uniform or if the uniform is lost while in the Athlete's Parent's care whether or not the loss was Athlete's Parent's fault, by theft, by acts of GOD or any other means; the uniform will be considered a loss. The Athlete's Parent will pay the Cleveland Mustang Track and Field Club the reasonable replacement costs of the uniform.
